1. **POC:** LO observed while reviewing records, one staff with no 121 form on file. Staff call while LO was present to see if she could get a copy from the local Health Dept. and was advised by LO to go and get her MMR's on a MSDH 121 form for employment. Staff was given until Aug 30 to get and send LO a copy of her MSDH 121 form.
