1. **POC:** During the facility review the staff were observed during lunch not wearing gloves in all classrooms. Gloves should be worn when opening lunch boxes and filling water bottles. The director will be responsible for ensuring that this violation is corrected. A follow-up will be conducted in 14 days.

Toddler Classroom Violations Cited

Class Room 3 - Classroom Number: 3

1. **Out of Compliance:** Child's hands are washed: (a) before and after eating, (b) after using the toilet or diaper change, (c) after playing on playground, (d) after handling pets, pet cages, or other pet objects, (e)

whenever hands are visibly dirty, (f) before going home. (Rule 1.12.3 & 1.18.1 Page 64)

2. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)
3. **Out of Compliance:** Employees wash hands before and after each diaper change. Individual or disposable towels are used for drying. Handwashing sink is used for handwashing only. (Rule 1.16.5 Page 77)

Toddler Classroom - Classroom Number: 3

1. **POC:** During the facility review the children's hands were not being washed after diaper changing. Technical Assistance was provided with the director and teachers to correct this violation. A follow-up will be conducted in 14 days.

2. **POC:** During the facility review the changing table was not being cleaned between each child. Technical Assistance was provided with the director and teachers to correct this violation. A follow-up will be conducted in 14 days.

3. **POC:** During the facility review the teacher wore the same gloves during diaper changing time with each child. Technical Assistance was giving with the director and teachers to correct this violation. A follow-up will be conducted in 14 days.
