Deficiency: Rule 1.13.6 states in part each child care facility must have a certified food manager meeting the standards set forth in Rule 1.2.2 (1)(g) The only exception would be if two facilities had completely different operating hours.

Findings: The LO observed a qualified food manager from Circle of Friends Learning Center II located in Brandon. The two facilities have the same operating hours therefore the certified food manager cannot serve at both facilities.
