Plan of Correction

1. **POC:** During review of records, CCFI observed four children and one caregiver that need updated 121s. The facility will have updated copies on file at the facility by June 1st. When received, updated copies will be sent to CCFI. If the facility does not have updated copies by June 1st the children and caregiver cannot return to the facility until they do.

2. **POC:** During review of records, CCFI observed two caregivers that did not have qualifications on file. The facility will have these qualifications on file by May 25th. Once received, the facility will send copies to CCFI. If qualifications cannot be found for the caregivers, they can only be caregiver assistants and cannot be left alone with children.
