1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)

Plan of Correction

1. **POC:** The outdoor playground area shall be enclosed with fence. The fence shall be at least four feet in height. There shall be at least two exits from such areas, with at least one remote from the building. Then-gate latch or securing device shall be high enough or such a type that it cannot be opened by small children. The licensing official one side of the fence was down. The director will be responsible to ensure that the fence will be back up by 06-19-2022.
