 POC: During observation of records, the facility failed to assure that they had a current MSDH 121 on each employee and child. Record review revealed six children records needed updated MSDH 121. There were four staff members that lacked a current MSDH 121 form. The person responsible is Director, Sherrie Sullivan. Compliance due for completion on children in 14n days on November 28, 2022. Staff need their MSDH 121 immediately and cannot return to work until they have one.
