Ones - Classroom Number: 3

1. **Out of Compliance:** Extension cords are not accessible to children. (Rule 1.11.1 Page 53)
2. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)
3. **Out of Compliance:** Extension cords are not accessible to children. (Rule 1.11.1 Page 53)
4. **Out of Compliance:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

Toddler Classroom - Classroom Number: 3

1. **POC:** Thermometer will need to be placed on wall at child's height. Diaper changing station will need a new pad. This one is torn. Shelf will be removed from in front of door and cords will be repositioned so they are inaccessible to children.
