- 2. **Out of Compliance:** All staff members have mandatory 15 contact hours on file (no more than five hours of in-house training may be provided by the child care facility. Acceptable topics for training may include: (a) health and safety, (b) child growth and development, (c) nutrition, (d) planning learning activities, (e) discipline, (f) linkages with community services, (g) communications with families, (h) detection of child abuse, (i) advocacy for early childhood programs, (j) professional issues. (Rule 1.5.8 Page 25)

- 2. **POC:** Observed while reviewing records that one child has no MSDH 121 on file. Director/owner will ensure this child does not return to facility without a MSDH 121.

3. **POC:** Observed while reviewing children's records, that 2 children had out of date MSDH 121s. Director/owner will ensure that these two above will be updated within 15 days for the child to remain in center.

Plan is reviewed at least once every 12 months. (Rule 1.20.2 Page 87)

#### Room 4 - Classroom Number: 4

- 1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
- 2. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)
- 3. **Out of Compliance:** Ceiling, Floor, and/or floor covering is properly installed, kept clean, in good condition, and in good repair. (Rule 1.11.1(8) Page 51)
- 4. **Out of Compliance:** Glass doors, windows, and mirrors, etc. have a protective barrier at least four feet high when measured from floor. (Safety grade glass or polymer (e.g., Lexan) is not required to have a protective barrier. (Rule 1.11.1(11) Page 51)
- 5. **Out of Compliance:** Walls are kept clean and free of torn wall covering, chipped paint, broken plaster, and holes. (Rule 1.11.1(12) Page 52)

#### School Age Room - Classroom Number: 4

1. **POC:** Observed holes in wall and some paint chipping. Director will have holes and chipping repaired. L O will return after the agreed time frame to ensure this has been done.

2. **POC:** Findings - Observed outlets not coved. Provider will do a daily room inspection to ensure all outlets are covered. Classroom will have stored away extra outlet covers.

3. **POC:** Observed window broken and safety film coming off. Director/owner will have these corrected in 30 days. LO will return to check that this has been completed.

4. **POC:** Observed school age classroom unattended while caregiver came to door to let LOs in. Caregivers will complete trainings on child supervision. This will be completed within 30 days.

5. **POC:** Observed 6 children in the school age room left attended while the director left the room to let the CCFI and BDD in the facility. The director returned immediately to the classroom. The director was also observed in the kitchen leaving the 6 children unattended a second time. This was corrected on site by the director returning to the classroom. A second caregiver arrived so the director could prepare lunch. Director/owner will ensure enough staff is present to ensure all children are supervised at all time. The

director/caregiver will line up the school age children and walk to the front door to let people in if needed.
