Findings/Comments The licensing official met with Caregiver, Sharlisa Williams and director, Botaniel Nelson.
The purpose for this visit was for a visit for a renewal and technical assistance visit.

Subchapter 25: Hearings, Emergency Suspensions, Legal Actions and Penalties

Deficiency: Rule 1.25.9(21) states in part, "Failure to have proper (up-to-date) immunization documentation in each child's record."

Findings: The licensing official observed during the children's records check that (1) child's MSDH 121 form had expired and (9) children did not have a MSDH 121 form on file.

POC: Director Botaniel Nelson will be responsible for contacting the parents to get a copy of the MSDH 121 forms. The provider has (14) days from today's date to submit a copy of (10) children's MSDH 121 forms to avoid a possible monetary penalty.

TA: Technical Assistance was provided on Rule 1.25.9(21) Immunization

Subchapter 15: Transportation

Deficiency: Rule 15.2(2) states in part, "Transportation requirements is that all vehicles have current safety, inspection stickers, license, and registration and insurance adequately covers the transportation of children."

Findings: The licensing official observed the Proof of Vehicle Insurance had expired 4/1/18.
