Infant Classroom Violations Cited

<u>Infants - Classroom Number: 1</u>

- 1. Out of Compliance: Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)
- 2. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
- 3. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)
- 4. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
- 5. **Out of Compliance:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
- 6. **COS:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)
- 7. **COS:** Space for creeping, crawling, toddling, and walking is available: (a) room not overcrowded with equipment, (b) time spent in strollers, swings, & bouncers is limited for infants who are awake, (c) activities that require extended sitting or standing are limited to 30 minutes, and (d) strollers only used when necessary. (Rule 1.9.6 Page 42)
- 8. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)

<u>Infant Classroom - Classroom Number: 1</u>

1. **POC:** Uncovered outlets will be covered today July 6, 2022. Items touching will be positioned/placed so they do not touch. Director will have cubbies/crates for items by Friday July 8, 2022. Thermometer will be placed on wall at child's height today July 6, 2022. Daily Reports will be started at beginning of day beginning today July 6, 2022. Items (pillow) observed in cribs were removed during visit. Bottles will be labeled with child's name and date. July 8, 2022. Infants will not be allowed to sleep in swings. Infant was removed from swing and placed in crib.
