2. **Out of Compliance:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)

1. **POC:** Licensing observed EHS rm #2 classroom failed to provide a daily written infant report. Facility classroom is asked to properly provide a written daily report during all times.

2. **POC:** Licensing observed assigned cribs as well as cots in classroom, however (2) children were observed sleeping on classroom rug. Licensing proceeded to ask lead teacher Dorian Ray and program aide Mylissa White if the two observed children had assigned sleeping areas. Per Dorian Ray, one child has a cot however the child will wake up when placed on cot. Per Dorian Ray, the other child has a assigned crib, but will also wake up when he is placed in the crib. Per Dorian Ray, she does not like to place the child in the crib due to the window being airy. Licensing asked Ms. Ray to possibly move the crib away from the window but Ms. Ray did not respond. Ms. Ray proceeded to place both children on their assigned crib and cot.


