# **Program Administration Violations Cited**

1. **COS:** Safe sleep policy is in place. (Rule 1.9.4 Page 41)

2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)

#### Plan of Correction

1. **POC:** Based on observations and review of staff and children records, the facility failed to assure that they had a current MSDH 121 on each employee and child. Record review revealed nine children record lacked a current MSDH 121 form. The facility has14 days to update all records and send to licensure at mary.hampton@msdh.ms.gov.

1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)

2. **Out of Compliance:** Playground has at least two exits with one remote from buildings. (Rule 1.11.9(5) Page 60)

1. **POC:** Based observation during walkthrough playground one is not in use at this time. Playground two will be used for gross motor activity until playground one is completed. A plan of correction for playground one will be submitted by June 1,2022 for review. Please review appendix D for adequate playground measurements and equipment.

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the appropriate staff-to-child ratio by leaving children unattended. There was one child alone in after school classroom with no caregiver present. Director was not aware child was in classroom and will monitor children more closely. Head count and sign in sheets will be monitored.
