Program Administration Violations Cited

Infant Classroom Violations Cited

Infant - Classroom Number: 4

1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
2. **COS:** Doorways and exits are free of debris and equipment to allow unobstructed traffic to and from room. (Rule 1.11.3 Page 55)
3. **COS:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
4. **COS:** Space for creeping, crawling, toddling, and walking is available: (a) room not overcrowded with equipment, (b) time spent in strollers, swings, & bouncers is limited for infants who are awake, (c) activities that require extended sitting or standing are limited to 30 minutes, and (d) strollers only used when necessary. (Rule 1.9.6 Page 42)

Infant Classroom - Classroom Number: 4

1. **POC:** Doorways free of debris and equipment- Director agreed to remove items. COS This same deficiency was cited on 12/8/22. Cribs labeled-Director agreed to label cribs at the end of day. Unattended Children Rule 1.8.1 (2) Children shall not be left unattended at anytime. There were 3 children alone in a classroom with no caregiver present. The caregiver was in the kitchen. This was corrected when caregiver returned TA was provided. TA was provided on infant sleeping in swing. Swings are only to be used while the children are awake once sleep they must be removed and placed in crib. COS

1. **POC:** Unattended Children Rule 1.8.1 (2) Children shall not be left unattended at anytime. There were 7 children alone in a classroom with no caregiver present. The caregiver was outside when licensing official arrived. This was corrected when caregiver returned to classroom TA was provided.


