It was explained that all volunteer must sign in and out daily to keep record of how many hours are worked per year. This was also documented on the last inspection on 1/12/23 for the same worker. Documentation must be submitted to licensing official before this worker can return MS Form 121, and a Fingerprint letter of suitability. explained that the worker cannot return until valid 121 form is on file at the facility.
