Program Administration Violations Cited

1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)

Plan of Correction

1. **POC:** Subchapter 5: Personnel Requirements Rule 1.5.2 (3a) states in part "Unless otherwise voided, the letter confirming an employee's Suitability for Employment is valid for a period of five years from the date of the letter" Findings: During the record review the licensing official observed one staff with an expired letter of suitability on file. This staff was asked to leave the facility until a current letter is on file. Technical assistance was given on how to complete the online child abuse registry form. This staff is not allowed back at the facility until a current letter is on file. Proof of this letter should be sent to the licensing official by the timeframe given. A follow up may be needed.

1. **Out of Compliance:** Daily reports are made available for toddlers and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)

1. **POC:** Technical assistance was given on starting the daily report for each child upon arrival and making sure that these reports are updated throughout the day. It was also explained that these reports should be sent home with the children each day.

Preschool Classroom Violations Cited

Three- Nine Year Olds - Classroom Number: 1

1. **Out of Compliance:** Preschool children are not mixed with school age children in any single area during normal classroom, playground or water activities. (Rule 1.8.2 (3))

Preschool Classroom - Classroom Number: 1

1. **POC:** Upon arrival, the licensing official observed three school-age children mixed with six preschool children during nap time. It was explained to Ms. Jordan that school-age and preschool children should not be mixed at any time during the facility's hours of operation. Per Ms. Jordan, the children were mixed to keep the boys and girls separate. Technical assistance was given on keeping the boys and girls separated in the same classroom. Due to the children being asleep in this classroom, it was explained that once nap time is over the three school-age children are to return to their classroom.
