1. **POC:** Based on observation while touring the building all cribs had a blanket covering each child. The infants are not to have blankets. Only the fitted sheet during nap time. Please be advised that the blankets can not be used to prop bottles at no time. Director will leave all blankets in diaper bags when brought to the facility to prevent this from occurring again.

Room Three - Classroom Number: 3

1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)

2. **Out of Compliance:** Sleeping infants are in view of staff and checked visually regularly. (Rule 1.9.4 Page 41)
3. **Out of Compliance:** Infants are dressed in clothing appropriate for sleeping without head covering or entrapment. (Rule 1.9.4 Page 42)
4. **Out of Compliance:** Infants are held while being bottle fed. Bottles are not propped at any time. Infants who are old enough and capable of holding a bottle may feed themselves without being held. (Rule 1.18.2 Page 81)

Infant Classroom - Classroom Number: 3

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the minimum staff-to-child ratio in classroom 3. There was 1 staff with 7 infants in ROOM 3. Per regulations, the minimum staff-to-child ratio for Infants are 1 staff to 5 children. This resulted in the facility being 2 children over ratio.
