1. Out of Compliance: All child records are present and up-to-date. (Rule 1.6.7 Page 32)

1. **POC:** 3 children had missing form 121's. Children may not return to the facility until forms are on file. Director will be sure to have a binder with all children form 121's on file. She will check monthly to ensure the form 121's are in compliance.

# **Playground Violations Cited**

- 1. Out of Compliance: Playground area is clean and free of hazards. (Rule 1.11.11 Page 61)
- 2. Out of Compliance: Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)
- 3. Out of Compliance: Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

Plan of Correction

1. **POC:** Caregivers should be doing daily playground checks before entering the play area. Licensing official observed several sticks on the playground and vegetation growing through the surfacing. Director stated that she will get the yard man to clean playground and moving forward the caregivers will do a thorough walk throughly of playground before entering. It is recommended that the facility get asphalt to prevent grass from growing through walkway. Walkway shall be a smooth walking surface. Pressure wash playground equipment. Spread surfacing under swigs and under slides to level surfacing out. Re-spray paint roots from trees.
