Findings/Comments Upon arrival the licensing official was greeted by the director. The licensing official explained the reason for her visit is to conduct a follow up on the kitchen and building. P.O.C. On child care encounter on 11-18-20 and 12-30-20 rule 1.11.3(1) The child care facility shall comply with regulations promulgated by division of sanitation of MSOH for food service. The kitchen dishwasher and refrigerator need to be replaced. During the facility review on 2-19-21 the decision was made to move all of the children to the Old Pearl River Infant and Toddler building. Pearl River Day Care experienced a pipe break in the center causing water damage in all classrooms. The ceiling in the office and kitchen pantry fell which caused damage to office equipment. An update was sent to the licensing official on 2/12-21 as of right now we still don't have the new appliances yet. They are on order. We had the table measured for the new dishwasher but waiting for hotel regulations and supply to deliver and install. The licensing official observed the table and refrigerator repaired.
