### Program Administration Violations Cited

### Kitchen Violations Cited

1. **Out of Compliance:** Food received from approved source is properly sealed and properly stored once opened from its original package (i.e., labeled and dated). (FC 3-101.11 & 3-202.15)

#### Plan of Correction

1. **POC:** Licensing observed frozen unknown food in freezer area of refrigerator. Licensing provided TA on the importance of properly dating and marking food items. Facility could not provide a timeframe on how long food was in the refrigerator. Licensing recommended that food be immediately thrown out. Director was observed tossing unknown undated food in trash.

### Nutritional Guidelines Violations Cited

1. **Out of Compliance:** Caregivers do not eat foods outside of the foods served in the facility in front of the children.
2. **Out of Compliance:** Are there any substitutions shown on menus? (These shall be of comparable food value and shall be recorded on the menu and dated)

#### Plan of Correction

1. **POC:** Licensing observed staff eating pizza and wings after lunch hours in front of children. Technical assistance was provided on the importance of eating alongside children during lunchtime & also why you should not eat in front of children. Licensing recommended that staff is allowed to eat it in a designated break area if staff to child ratio is maintained.

1. **Out of Compliance:** Adequate shade is present on playground area. (Rule 1.11.9(7) Page 60)

1. **POC:** Licensing observed inadequate shading on playground. Shading was observed torn. Per director, the shading was torn by a recent storm, however she has ordered new shading. Facility is asked to replace shading and send picture documentation within 20 days.


