1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** During the facility review the hot water in classroom 3 and 4 was in need of hot water. The director/owner will be responsible for ensuring that the hot water is repaired. During the facility review a work order was put in to tribal maintenance. A follow-up will be conducted in 14 days. A maintenance policy will be put into place to ensure violation from reoccurrence.

2. **POC:** During the facility review the licensing official observed the sinks in classroom # 5 in need of repair. The sink overflowed due to the sink being stoped up. The sink faucet on the sink is in need of repair. Water flows out ths sides of the facuet. A maintenance policy will be put into place to ensure compliance. During the facility review the dirctor designee called tribal maintenance. A follow-up will be conducted in 14 days.
