2. **Out of Compliance:** Adequate shade is present on playground area. (Rule 1.11.9(7) Page 60)
3. **Out of Compliance:** Concrete footings are at least six inches below ground surface. (Rule 1.10.2(2) Page 46)

#### Plan of Correction

1. **POC:** Based on observation while touring the facility playground, the facility failed to ensure that playground fence was in good repair. The fence is coming apart at the building #1 and building #2 the gap is more than 3 1/2 inches from the playground surfacing No shade is present on playground #2 , shade needs to be replaced at building #1 All concrete footings must be at least six inches below ground

surfacing, the licensing official observed concrete footings above ground surfacing at building #2 observed ant beds on playground #1 observed overgrowth bushes on fence at building #1 The director will be responsible for having playground corrected within 30 days.
