Tree roots shall be high lighted to prevent trip hazards.

Items Needed: 2-4 weeks of menu on menu form, a copy of a CPR-First Aid card, contact hours, Fire Form, updated insurance card for vehicle, and the acknowledgment form for renewal.

Complete online application on or before NOV. 30, 2020, and Pay fee.
