2. **Out of Compliance:** Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

1. **POC:** The licensing official observed the playground fence had a large hole or gap on the side. The playground fence should be repaired before the children utilize the playground area.
