3. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. ### Plan of Correction

1. **POC:** Licensing official observed 2 staff, one staff with no letter of suitability on file, one staff with an expired letter of suitability. Owner and designee was informed that staff shall not return back to work until a valid letter of suitability is provided. Staff was not present during inspection visit. Date of completion: 10/7/2022 No staff was present on site at the facility with CPR/1st aid. Per the designee, all staff are signed up to take a face to face training on 10/11/2022. 3 staff will need an updated MSDH 121 form. two staff did not have a MSDH 121 form on file(staff shall not return back to work until a valid MSDH 121 is provided). one staff had an expired MSDH 121 form (date of completion: 10/7/2022). Per the designee, she will notify the staff on today to get updated MSDH 121 form submitted.
