Upon arrival, caregiver # 1 was attending eight (8) infants in classroom 102. Additional staff arrived at 9:00 am to assist in classroom 102. Per regulations, the minimum staff-to-child ratio for infants is one caregiver to five (5) infant children. This resulted in three (3) children over ratio. (\$50.00 X 3= \$150.00)


