direct supervision (staff in same room) of
50 percent of the staff required by this
section during rest period times."

Findings: Observed (12) twelve children ages
one year to two years old sleeping in room
#3 under the supervision of one staff person.
This resulted in the room being over staff
child ratio by (3) three children.

DOC (COS): Director Katie Archenbach placed another
staff person in the room immediately.

Ms. Archenbach will be responsible for ensuring
the one year old room stay within ratio
at all times, and states that when more than
nine children are present, two teachers will
be in the room at all times, including, rest
time.

Subchapter 10 Equipment, Toys, and Materials

Deficiency: Rule 1.10.9(7) states in part "children are not allowed to sleep in shared spaces."

Findings: Observed ~~one~~ two children in the infant room sleeping in bouncer seats.

POC(COS): The caregiver immediately moved the children to their individual beds. Director Katie Aschenbach will hold a meeting with staff and implement policy to make sure infants are always moved to their bed when sleeping.
