### Program Administration Violations Cited

1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)

#### Plan of Correction

1. **POC:** Letter of suitability-based on observation during record review, the facility failed to conduct the required criminal history records check, for 1 employee. This 1 employee was alone in separate classroom providing unsupervised care to the children. This was corrected by the children in classroom #2.

### Infant Classroom Violations Cited

#### Infant - Classroom Number: 4

1. **Out of Compliance:** Doorways and exits are free of debris and equipment to allow unobstructed traffic to and from room. (Rule 1.11.3 Page 55)
2. **Out of Compliance:** Thermometers that are not hazardous to children are placed on interior walls at children's height. (Rule 1.11.8(9) Page 58)
3. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
4. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)

#### Infant Classroom - Classroom Number: 4

1. **POC:** Thermometer-This same deficiency was cited on 11/16/22 director/owner agreed to purchase thermometers at the end of the day. Doorways free of debris and equipment- Director agreed to remove items. COS Daily sheets-Director agreed to make copies and ensure daily sheets are completed daily throughout the day for children 1 and under. Bottles labeled-Director agreed to ensure each child name and date is placed on infant bottle during arrival.
