1. **Out of Compliance:** Facility has appropriate number of operational toilets and handwashing lavatories. A ratio of 1:15 is required. Each sink is supplied with hot and cold running water, soap, and individual towers for drying. Each toilet is supplied with toilet paper. (Rule 1.11.5 Page 56)

Plan of Correction

1. **POC:** During the inspection the licensing official observed one toilet in the girls restroom not working. Per Ms. Haymer the toilet was turned off because it is leaking. (3) days are giving to make the needed repairs to this toilet to prevent the facility capacity from decrease.

1. **Out of Compliance:** A Certified Food Manager or designated person in charge is present who can demonstrate knowledge and perform duties. (FC 2-101.11, 2-102.11, & 2-103.1)

Plan of Correction

1. **POC:** During the inspection the licensing official observed that this facility does not have a certified Food Manager. During the facility virtual renewal on 07 /08/2020 it was informed to the director that a food manager certification was needed. During this time the tummy safe test was not being given due to COVID 19. The licensing official explained during this time that once the test taking start back that she will have to call and set up a appointment to take the test. Due to this not happening the facility now has to submit their food manger certification by the date given.
