1. **Out of Compliance:** Individual hooks or compartments are provided for each child to store personal possessions. Hooks are spaced so belongings do not touch and are at a height suitable to prevent injury. (Rule 1.10.5 Page 47)
2. **Out of Compliance:** Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
3. **Out of Compliance:** Formula is labeled with child's name, dated, and placed in refrigerator upon arrival. (Rule 1.18.3 Page 81)
4. **Out of Compliance:** Food stored or prepared in jars is served from a dish separate from storage jar. Leftovers in jar shall be labeled with: (1) child's name and (2) date opened. Leftovers must be used within next 24 hours or discarded. No food placed in serving dish shall be stored or reused. (Rule 1.18.4 Page 81)

1. **POC:** Designee will get with Director to purchase hooks and have them installed so children can hand their belongings. This way the children belongings will not touch. Completion date will be Monday, April 11, 2022 Cribs will be labeled with child's name by Friday, April 8, 2022 Bottles will be labeled with child's name and dates. April 8, 2022 Cereal will no longer be added to children's formula. Children will be spoon fed. April 8, 2022 Leftovers in jar will be labeled with child's name and date. April 8, 2022 Children will only be in highchairs during feedings. April 8, 2022 Leftover baby food will be labe
