1. **POC:** Provider has a wooden area within the classroom which children are placed. The Director will get with the owner to determine if she wants to keep the area. If so, i would have to remeasure that room to get a new room capacity. Children were observed sitting in high chairs for instruction time. Staff removed children from highchairs. Classroom has two light fixtures with blown bulbs. Bulbs will be replaced by Friday, April 21, 2023.
