1. **POC:** During the inspection, the licensing official observed that the barrier located around the play equipment on the far right side should be removed or replaced. Fencing was also observed on the play area that should be removed as well. Per the director Ms. Anderson the facility is currently working on removing the barrier and the extra fence. In March they will begin the last phase of renovations to the playground area.

Technical assistance was given on removing the cover and placing the child on their back while they are asleep. This was corrected while the licensing official was present.
