Program Administration Violations Cited

1. **Out of Compliance:** Facility has adequate heating, cooling, and ventilation. (Rule 1.11.8)
2. **Out of Compliance:** Facility has not made any major changes without notification to child care licensure division. (Rule 1.4.4)

Plan of Correction

1. **POC:** The following has been corrected from previous inspection: Provider has an updated staff and Children's roster. Upon arrival, director informed licensing official the air was inoperable on one side of the building. Three classrooms (infant, toddlers, and twos) are currently without air. Director stated the air went out yesterday afternoon around 2:30 pm. She also stated parents were called and some came to pick their children and Three children remained at facility. While licensing official was present, technicians arrived to repair air conditioning unit. Director was reminded she is required to inform licensing official of any changes within facility. Licensing official spoke with technician to inquire when air will be repaired and he stated it would take most of the day. Therefore, licensing official and Director moved children around in facility to accommodate all children present today. Director was informed if air isn't repaired today she can not accept infants, ones and twos tomorrow or until unit is repaired.

1. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

Plan of Correction

1. **POC:** Director purchased playground equipment without licensing official's knowledge and approval. Before equipment can be used by children, surfacing will need to be installed and three of the pieces will need to be bolted down.
