During the inspection, the licensing official observed that one staff did not have a letter of suitability on file. This staff was sent home and another staff was placed in their classroom. Due to the facility being closed for spring break, they have until March 23, 2023, to submit the current letter. This staff is not allowed at the facility until a current letter is on file.
