Infants - Classroom Number: 2

1. **Out of Compliance:** Evacuation route is posted in classroom. (Rule 1.4.6(d) Page 18)
2. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
3. **COS:** A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

Infant Classroom - Classroom Number: 2

1. **POC:** During the inspection, the licensing official observed that the evaluation plan should be posted on the classroom wall. Technical assistance was also given on starting the infant's daily reports once they arrived at the facility to keep the parent informed of their child's behavior throughout the day.

2. **POC:** During the inspection the licensing official observed that a smooth surface is needed on the diaper changing tables when changing the children in the infant and two year old classrooms. It was observed that the children are placed on the tables when being changed but the paint from the table has begun to peel causing it to not be a smooth, safe surface. This was corrected on site by place a mat at both diaper changing tables
