Preschool Classroom - Classroom Number: 2

1. **POC:** Upon arrival at the preschool classroom, the licensing official observed that the wall thermometer temperature was reading 80 degrees. One fan was observed working in this classroom. The children in this classroom were down for a nap with the classroom door open, but due to the classroom being hot the caregiver had to turn on another fan to help the classroom cool off. This temperature was also observed in the infant classroom and two-year-old classroom. The licensing official explained to the director and owner that vents in the classroom were not circulating any cool air if not any air in some spots. It was explained that the only cool air in the classrooms was from the fans. Per the owner, Mr. Roosevelt the hallway air system was turned down to allow more cool air to enter the classrooms, and the caregivers were also told to keep their doors open so that the air from the hallway could help to keep the temperature down in the classrooms. A follow inspection of the wall thermometer was taken again in the preschool classroom but the temperature was still the same. The licensing official informed the director to move the children from this classroom into another part of the building where the air is working to comply with regulations. Fans were placed by the infant and two-year-old classrooms to help the airflow into these classrooms cooling them down. Mr. Roosevelt stated that he had called his Air repair person and that they would be at the facility at 3 today July 19, 2022, to repair the circulation issue in the classrooms. A follow-up inspection will take place to make sure that the issues have been corrected.
