The licensing official observed the staff immediately remove the raw eggs and move them to the bottom of the refrigerator.2) Who will be responsible for making sure the recurrence of the violation does not happen again? Per Mrs. Kim, she immediately removed the eggs.3) What is the expected completion for the compliance? 4/16/2019A green child care survey card was left with Kohantez Barney.Class I and II violations may result in a monetary penalty.
