1. **Out of Compliance:** Appropriate surfacing material is present and meets minimum required compressed loose-fill surfacing depths (e.g., 6 inches for shredded/recycled rubber; 9 inches for sand, pea gravel, wood mulch (non-CCA), and woodchips). (Appendix D 2.4 & 2.5 Page 8-10)

1. **POC:** Licensing official observed inadequate surfacing on playground. Between 6 and 9 inches of pea gravel is needed. Owner stated more gravel will be dumped on or before 10/21/2022.
