1. **POC:** Rule 1.2.10 states ???The current license issued by the licensing agency to the named childcare facility and operator shall be posted and displayed in a conspicuous place and in easy view of all persons who enter the childcare facility. The facility operator shall also post next to the license, in plain view, a notice provided by the MSDH that informs the public of where and how they may report a complaint against the facility. Findings: Based on observation during a walk through, the facility failed to post license in facility for viewing, correction made before inspector left.

- 1. **Out of Compliance:** Proper staff to child ratio maintained. (Rule 1.8.1 Page 37)
- 2. **Out of Compliance:** Sleeping infants are in view of staff and checked visually regularly. (Rule 1.9.4 Page 41)
- 3. **Out of Compliance:** Infants are dressed in clothing appropriate for sleeping without head covering or entrapment. (Rule 1.9.4 Page 42)
- 4. **Out of Compliance:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

<u>Infant Classroom - Classroom Number: 3</u>

1. **POC:** Based on observations while touring the facility, the facility failed to maintain the appropriate staff-to-child ratio by leaving children unattended. There were 4 children alone in classroom 3 with/ no caregiver present. The staff will make sure there's a person in each classroom before leaving. Staff will never leave classroom if no one is taking their place. Ratio corrected prior to inspector leaving.

2. **POC:** Based on observation during walk through blankets and propping items where observed in cribs while infants slept. Regulation observed concerning items in crib. All items were removed immediately and technical assistance provided. Staff and director will monitor the cribs and infant to follow proper SID protocol.
