1. **Out of Compliance:** All child records are present and up-to-date. (Rule 1.6.7 Page 32)

1. **POC:** During the inspection the licensing official observed six children with expired 121 forms. The facility has until the timeframe given to submit current forms.

Playground Violations Cited

1. **Out of Compliance:** Tree limbs and other suspended hazards at least seven feet above play surfaces. Fence is free of brush and overgrowth. (CPSC 3.5 Page 16)

Plan of Correction

1. **POC:** During the inspection the licensing official observed that the overgrowth on the fence should be removed. The opening located by the afterschool back door should be repaired or replaced to prevent animals from coming onto the playground area. Technical assistance was given on spraying highlighter paint on the exposed tree roots. This should all be completed by the timeframe given.

1. **POC:** During the infant inspection, the licensing official observed power formula in the classroom. Per the caregiver, bottles are made when needed in the classrooms. Technical assistance was given on using ready-made formula only and making the bottles in the kitchen and not the classroom. Please note that per Regulations Appendix C " when centers are reimbursed for meals and must supply formula for their infants, only ready-to-use formula may be purchased for use" Also note that if a warmed is needed the cords should not be exposed to the children. Technial assistance was given on laying the infants on their backs when sleeping.
