2. **Out of Compliance:** All vehicles have current licenses and registrations. (Rule 1.15.2 Page 75)

1. **POC:** During observation of the facility transportation vehicle, LO observed expired tags on two of the facility vans. The director stated people are stealing the current stickers off the tags. Technical Assistance: Recommendation for the director to remove the tags at the end of the day and place them back at the beginning of the morning.

2. **POC:** During observation of the facility records, LO observed 2 staff and 4 children with no form #121, and 6 children with expired form #121.
