1. **POC:** Ms. Grandberry will meet with staff to explain the importance of children being supervised at all times. So long as a staff member is sitting at the common room/area desk, children may walk from gym to play care area. However, a staff member with a valid Letter of Suitability must be present at the desk. Likewise, children may exit homework/activity room to cross into the play care area as long as a staff member with valid LOS is present at common area desk and staff member in homework/activity room is at the doorway of the classroom and alerts staff person at desk. A copy of staff meeting notes, signed and dated by staff members will be sent to Licensure Official.
