2 - Classroom Number: 2

1. **Out of Compliance:** Unused electrical outlets are covered by safety plug covers. (Rule 1.11.1 Page 52)
2. **Out of Compliance:** Walls are kept clean and free of torn wall covering, chipped paint, broken plaster, and holes. (Rule 1.11.1(12) Page 52)
3. **Out of Compliance:** Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)


Infant Classroom - Classroom Number: 2

1. **POC:** Based on tour of classroom # 2, the facility failed to have protective wall outlet plug covers in all outlets accessible to children. Person responsible for maintaining compliance of listed deficiency is Shamika Martin, Owner/Operator. Compliance due immediately.

2. **POC:** Based on tour of classroom 2, the facility failed to have wall surfaces free of paint damage. Person responsible for compliance is Shamika Martin, Owner/Operator. Recommend repair and/or painting of entire classroom. Compliance due by October 7, 2021.  
**Person Responsible:** Shamika Martin **Date for Completion:** 14 Days
3. **POC:** Based on tour of classrooms and review of facility records. The facility failed to have daily report prepared for infant present. Person responsible for maintaining compliance is Shamika Martin, Owner/Operator. Compliance due immediately.
