Subchapter 8: Staffing

Deficiency: Rule 1, 8, 1(c) states in part, "The staff-to-child ratio shall be maintained at all times..."

Findings: Based on observation while touring the facility, the facility failed to maintain staff-to-child ratio in room 4. There was one staff with eleven children, the youngest was a 1-year-old, in room 4. Per regulations, the proper staff-to-child ratio for a 1-year-old is one staff to nine children. This resulted in being two children over ratio.

Findings: Based on observation while touring the facility, preschool children were in room 5 with one school age child. The school age child was away from the preschool children and not interacting with the preschool children.

Plan of Correction

The owner/director will create a classroom for school age children during the day if needed. gp
