1. **POC:** During observation of the facility records LO observed seven children with expired form #121, one child with no form #121, one child immunization needs to be transferred to a MS Compliance form #121, and one child that needs a form #121 or #122 for the religious exemption. The children with expired form #121, no form #121, religious exemption, and out of state immunization can not return/are not allowed into the facility until updated MS Compliance Form #121 are received. The facility has 14 days (09/11/2023) to submit updated form to LO.
