1. **COS:** Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

Infant Classroom - Classroom Number: 3

1. **POC:** Technical Assistance: Corrected-on-Site-During observation of the infant room, LO observed there were blankets covering 2 infants sleeping in cribs, and one of the infants was lying on a large towel in the crib. The director removed the towel and 2 blankets from the cribs. Please remind staff that regulations states nothing except the fitted sheet is allowed in the crib with infants.

2. **POC:** Technical Assistance: During observation of the infants room, LO observed there was no labels on infants bottles, a can of dry formula was observed in the room. And a gallon of regular milk was observed in the infant room refrigerator. Regulations states infant formula/bottles are to be prepared and labeled at home and brought to the facility and placed in the refrigerator. Regular milk is to be poured in infants cups in the kitchen, not the classroom according to regulations.
