#### Plan of Correction

1. **POC:** Based on tour of the facility's outdoor playground area, the facility failed to have fall zone surfacing material surrounding the playground equipment structures recently installed. Note: Never use less than 9 inches of loose-fill material except for shredded/recycled rubber (6 inches recommended).
