Program Administration Violations Cited

1. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. Plan of Correction

1. **POC:** License Official (LO)observed fire/disaster drills had not been conducted since February 2022. Director stated that she had not been conducting monthly fire/disaster drills on a monthly basis. LO informed the director that fire/ disaster drill according to MSDH regulations must be conducted monthly and the children an staff must exist the building under two minutes. Director must conduct a fire/disaster drill weekly until they are caught up with this current month. A copy of the updated fire/disaster drill can be emailed to LO by September 30, 2022.

1. **Out of Compliance:** Playground fence is less than 3 ½ inches from ground surface, in good repair with no gaps and secure gate latch. (Rule 1.11.9(8) Page 60)

Director stated that she will have her maintenance person repair or replace the area along the fence that is detached.
