1. **Out of Compliance:** Materials in infant room are age-appropriate to meet developmental needs (e.g., simple, lightweight, open-ended, easily washable toys, rattles, squeak toys, action/reaction toys, cuddly

toys, toys to mouth, pictures of real objects, crawling area with sturdy, stable furniture for pulling up self). (Rule 1.10.1 Page 41)

Out of Compliance: A proper diaper changing station is provided which includes: (a) hot & cold running water, (b) smooth, easily cleanable surface, (c) plastic, lined and covered garbage receptacle, (d) sanitizing & disinfecting solution. Handwashing sink is used only for handwashing. (Rule 1.16.1 Page 77)

#### Infant Classroom - Classroom Number: 2

 POC: During walkthrough of facility, CCFI observed one infant and one caregiver in Room 2. Room 2 is not set up as an infant classroom. CCFI did not observe materials to be age appropriate for infants. CCFI could not access max capacity worksheet in LARS to confirm if the sink in Room 2 was a hand washing sink or a diaper changing sink. CCFI contacted supervisor. Supervisor was in the field and could not access system. CCFI will discuss max capacity worksheet with supervisor and will contact Director on how to proceed. Per Director, she is going to move children to accommodate the infant in an appropriate room. Director will email CCFI a layout of what age children and ratios are in each classroom.
