1. **Out of Compliance:** All staff members have a valid Letter of Suitability on file. (Rule 1.5.2 Page 21)
2. **Out of Compliance:** All required facility records are present and up-to-date: (1) child and employee attendance records, (2) alphabetical roster of children, (3) alphabetical roster of staff and volunteers, (4) current license, (5) records of monthly fire /disaster drills, (6) medication log, (7) volunteer log, (8) notebook of 121 forms for staff members and children w/roster, (9) notebook with Letters of Suitability for all employees w/roster. (Rule 1.6.3 Page 29)

Plan of Correction

1. **POC:** Based on records reviewed for staff and children, the facility failed to maintain compliance on MSDH Form 121's for children enrolled. Record review revealed one (1) employee and three (3) children. Person responsible for compliance will be Sherita Rush, operator. Compliance due by November 19, 2021.

2. **POC:** Based on records reviewed for staff, the facility failed to maintain compliance on letter of suitability for one employee. Record review revealed one employee letter of suitability expired on 09/14/2021., this staff was not alone attending children. This letter of suitability was issued under different facility of origin. Person responsible for compliance will be Sherita Rush, operator. Compliance due by January 5, 2022.


