2. Daily reports are made available for infants and include: liquid intake, child's disposition, bowel movements, and eating and sleeping patterns. (Rule 1.7.4 Page 35)
3. Each infant is placed on a separate bed, crib, or mat. Cribs are labeled so that child's name is visible. (Rule 1.17.1 Page 79)
4. Infants are placed on firm mattresses covered by a fitted sheet, and no other items including pillows, blankets, sheepskins, bumpers, soft objects, stuffed toys, loose bedding, etc. is in the crib. (Rule 1.9.4 Page 42)

1. **POC:** Daily reports for parents were not available . Director will be responsible for ensuring caregiver is completing these throughout the day. Caregiver and director will be responsible for ensuring daily reports are available in the classroom each morning.
2. Technical assistance was given on no items in cribs, only a fitted sheet are allowed in the crib. Director and caregiver will ensuring no items are in cribs daily.
3. Technical assistance was given on cribs to be labeled so that child's name is visible. Director and caregiver will ensuring that each cribs will be labeled with each child name.


